> Our facility is strategically located in a offshore jurisdiction that has a long history of investor friendliness. We are close enough to major North and South American urban centers so that you can quickly access your holdings if need be. We believe that investors would prefer to achieve the internationalization of their assets without having them held in more distant storage facilities in either Europe or Asia.

**Proximity:** The Cayman Islands are located within a half-day's travel of urban centers in North, South and Central America. Major airlines including US Airways, American Airlines and British Airways provide daily flights arriving at the Owen Roberts International Airport in George Town. The airport is located less than one kilometre from the SWP facility.

**Politically Stable & Modern Jurisdiction:** The Cayman Islands are a British Overseas Territory that possesses both a stable and modern political and legal system, fully supported by the laws and military strength of the United Kingdom. The islands also boast a first-world level of infrastructure and professional services.

**Neutrality:** The Cayman Islands are not part of any global disputes and adheres to a policy of neutrality.
